

Typical efficiency is 86%, and the output is short circuit protected. When an output short is present, the power supply will try and switch on every 10 seconds. A power-on LED is provided.

The output connector is a 2.1 mm circular plug attached to a 24-inch-long cable. A 6-foot-long 120VAC power cord comes standard with the PS-48.



OUTPUT VOLTAGE VS. LOAD




